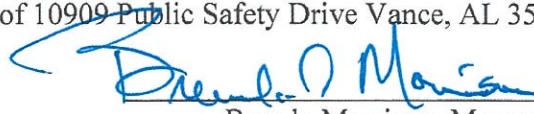

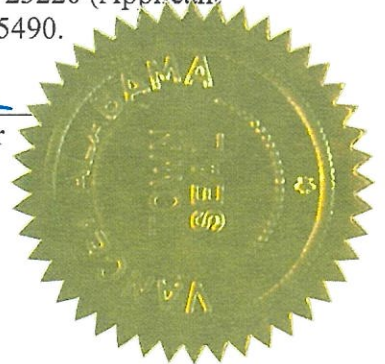

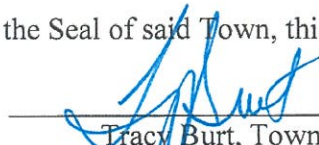

RESOLUTION NO. 07182022

WHEREAS, the Town of Vance has received an approved SAHD #2 Reimbursable Agreement from the Alabama Department of Transportation (ALDOT) to relocate sanitary sewers along Hwy 11, ALDOT project # ACSTAAF-0007(549); and

WHEREAS, in accordance with ALDOT regulations the Town of Vance has solicited and received bids from qualified construction companies to construct the above referenced sanitary sewers in accordance with the approved plans and specifications; and

WHEREAS the original contractor due to uncontrollable circumstances could not perform this contract as awarded in December, 2021, and the Town and ALDOT agreed to purchase certain materials the contractor had delivered to the site, and solicited bids to install these materials.

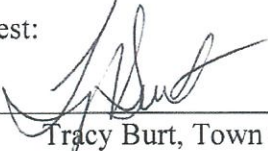
NOW, THEREFORE, BE IT RESOLVED, that the Town Council and Nelson Engineering Associates, have evaluated the bids received to install these Owner furnished materials, and have determined that Price Civil Services Inc is the low bidder; and

BE IT FURTHER RESOLVED THAT, Brenda Morrison, Mayor, be and is hereby authorized to award a construction contract to Price Civil Services Inc. for a total contract amount of \$360,885.50 to complete all of the sanitary sewer relocation activities associated with the above referenced project upon receipt of approval of award by the Alabama Department of Transportation.

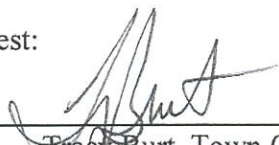

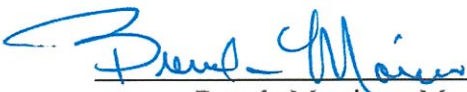
